Introduction

What is myQIportal?

This quality improvement project is approved by the American Board of Pediatrics (ABP) and qualifies for Maintenance of Certification (MOC) Part 4 credit for Performance in Practice. For more information on ABP approved quality improvement projects and MOC credit requirements visit <u>www.abp.org</u>.

This project involves the submission of 3 case sets. Each case set should consist of 5 consecutive sexual abuse cases you have evaluated. The submission of consecutive cases allows the reviewers to assess your present photographic technique and diagnostic skills, not just your difficult or tricky cases. After the submission of each case set you will receive feedback and be assigned interventions by a reviewer from our Expert Review Panel. You will have 1 month to complete the assigned interventions before submitting your next case set. Upon the completion of all 3 case sets you will be provided with a certificate of completion and a final report of your progress during the project.

What information will I need to submit a case?

- Patient demographic information
- History
- Physical exam findings
- Genital exam findings
- Anal exam findings
- Clinical images (A minimum of 2 images in the following digital still formats, JPEG, TIFF, BMP and GIF 500KB or greater or 1 Video file in the MP4 format)
- Diagnostic Impression

Submit Case Set 1

- 5 cases of Child Sexual Abuse with at least 2 clinical images AND a diagnostic impression
- Review of Case Set 1 by Expert Reviewer & Assignment of Interventions
- Completion of Intervention

Submit Case Set 2

(At least 1 month after Case Set 1)

- 5 cases of Child Sexual Abuse with at least 2 clinical images AND a diagnostic impression
- Review of Case Set 2 by Expert Reviewer & Assignment of Interventions
- Completion of Interventions

Submit Case Set 3

(At least 1 month after Case Set 2)

- 5 cases of Child Sexual Abuse with at least 2 clinical images AND a diagnostic impression
- Review of Case Set 2 by Expert Reviewer
- Completion of QI Project

STEP 6: In the box provide a detailed description of genital anatomy with location and detailed description of normal and abnormal findings. Click 'Save' and proceed to the anal exam.

STEP 7: In the box provide a detailed description of anatomy with location and detailed description of normal and abnormal findings. Click 'Save' and proceed to clinical images.



STEP 8: You must upload a **MINIMUM of 2** clinical images or **1 Video File**. Follow the instructions provided on the screen to upload images from your computer or wherever you have them saved.

NOTE: Acceptable image formats include JPEG and TIFF and we recommend files that are at least 500KPB or larger. Acceptable video formats are MP4.

Once you have uploaded images successfully, click 'Save' to view thumbnails of the images you have uploaded. Your screen should look like the one below and you can then proceed to making a diagnostic impression of the case.



STEP 9: In the box provide a detailed description of your diagnostic impression and select your diagnostic impression from the drop down list provided

NOTE: You <u>MUST</u> provide a diagnostic impression to complete the creation of a case. Once you click, ' Save', the case will be complete and you will no longer have the ability to edit any of the case information.

Intervention Completion

STEP 1: After the reviewer assigned to your project has completed the review of your Case Set and assigned interventions you will receive an e-mail notification. Follow the instructions in this e-mail and log back in to myQIportal to review your case rating scores, feedback and interventions.

You <u>MUST</u> complete each intervention thoroughly before checking the intervention complete. Each intervention will have its own set of instructions on the intervention page and they will vary in length and in material.

STEP 5: Once all interventions are complete, and it has been a minimum of 30 days since the submission of your preceding Case Set, you can then begin to create cases for your next Case Set and follow the steps outlined in Case Creation.

NOTE: You will receive an email notification once the minimum 30 Day period has passed and you are able to create your next Case Set.
