

2020 Peer Review | Registration Guide

Thank you for your interest in the Midwest Regional Children's Advocacy Center's National Peer Review Program. Here are some tips to guide you through the registration process.

Where do I go to register?

Visit mrcac.tfaforms.net/55 to register for the 2020 Peer Review Program (January 1-December 31, 2020). Registration closes on October 25, 2019.

What information will I need to provide?

- Basic organization information (name, location)
- Primary contact: This is the main point of contact regarding your site's participation in peer review and is responsible for forwarding all links and other communication to team members.
- Type(s) of peer review you want to join: See the next page for the peer review types.
- Recurring participation date/time: See the next page for the available sessions. Please note that regular attendance during your chosen session is expected and contributes to an improved educational experience for you and your fellow participants.
- Participant information: For Medical and SANE peer review, you'll need to provide the name, email address, and credentials (DO, MD, NP, PA, RN, SANE-A, SANE-P, NA, Other) of individuals who will be participating from your site.
- *Forensic Interview Peer Review Types Only*
 - Number of presentation slots: Each site is required to present at least once in each annual rotation, and sites with multiple interviewers who need to be peer reviewed may request a second presentation slot. If you require more than two slots, please indicate the number and we will try to accommodate your request.
 - System used for recording/storing video files: V2Advocate, iRecord, Xact Vision, etc.
 - Format of video files: mp4, wmv, avi, mov, Windows Media Player

How will I pay the \$150 registration fee for my site?

Payment is collected at the end of the registration form. Credit cards payments are preferred and are processed through PayPal. If you don't already have them, you will be prompted to establish a (free) PayPal username and password in order to process your credit card payment.
